Cov koob tsheej no, uas muaj tau kev ntsib tim nsteg tim muag, yog ib txoj kev tsim nyog yuav xaus rau lub xyoo nyuaj. Pom peb cov tub ntxhais kawm tau txais cov khoom plig kawg ntawm xyoo thiab daim ntawv qhia nrog cov niam txiv thiab cov neeg hauv tsev neeg tuaj koom yog qhov ceeb toom tseem ceeb uas ua tiav ASD lub luag haujlwm tseem ceeb yog txoj kev taug mus ntev uas yuav tsum muaj kev mob siab rau tag nrho lub zej zog.

Xav txog, txhim kho CDC cov kev taw qhia txog qhov tsis tshua muaj kis tus kab mob thaum lub sijhawm ua si sab nraum zoov, ASD tau tshem tawm qhov kev xav tau rau cov neeg tuaj yeem pab txhaj tshuaj tiv thaiv kab mob kom koom nrog kev ua si sab nraum zoov. Niam txiv cov neeg ua haujlwm pub dawb yog qhov tseem ceeb thiab muaj txiaj ntsig zoo rau tsev kawm ua ke, thiab kev hloov kho no yuav ua rau muaj kev koom tes dav ntxiv nyob rau xyoo xaus kev kawm tseem ceeb yam tsis muaj kev nyab xeeb. Lub District ua tsaug rau kev txhawb nqa zej zog thiab ua tsaug rau zej tsoom cov lus qhuab qhia vim tias peb ua haujlwm ua ke txhawm rau rov mus ua ub ua no.

Peb cia siab tias yuav muaj qee cov kev tswj kom txo qis, vim kev nyab xeeb ntawm cov tub ntxhais kawm thiab cov neeg ua haujlwm yuav tseem yog District qhov tseem ceeb. Peb tseem yuav taug CDC cov lus qhia thiab qhov yuav tsum tau muaj ntawm peb lub nroog raws li peb npaj. Cov tsev neeg uas xaiv mus nrhiav tshuaj tiv thaiv rau lawv cov tub ntxhais kawm tuaj yeem teem caij mus txhaj tshuaj tiv thaiv los ntawm lub Alaska Department of Health and Social Services. Thov nco tias kev txhaj tshuaj tiv thaiv tseem yog ib qho kev xaiv ntawm ASD.
