Member Anglin: Motion to rescind the vote from April regarding the 2.0 FTE approved and vote for each allocated FTE separately. Herr Phillips seconded.

Discussion: Separate out to vote for the positions separately. We have paraprofessionals that are super supportive of our students and help but this is above and beyond their scope. A librarian would be able to help so that paraprofessionals in the classroom could provide more support for teachers. Librarian is a student-facing position that can help in a variety of ways. The Rilke Schule position is for Rilke Schule - focused on literacy, resources for English/German books.
